DESCRIPTION

GREVEN® LOTION D has been developed for the care and the regeneration of stressed skin and is suitable for normal to dry skin types. GREVEN® LOTION D is based on an oil-in-water emulsion. It is medium greasy, absorbed quickly and it does not leave an annoying greasy film on the skin. Moreover, the product is vegan and free from silicones.

Skin stressed by the environment and by influences at the workplace is damaged due to a loss of moisture and lipid substances. This kind of permanent damage can only be compensated to a certain degree by the skin's natural regeneration capacities. As a result, skin damage and premature ageing of the skin can be observed. GREVEN® LOTION D protects against this work-related skin ageing and provides the skin with moisture and lipids. Additionally, the skin is treated with moisturizing allantoin. The cream contains panthenol which has an anti-inflammatory effect and supports the healing of wounds. GREVEN® LOTION D PURE is HACCP compliant and, thus, it is especially suitable for the food industry.

APPLICATION

Apply GREVEN® LOTION D after work on the previously cleaned and thoroughly dried skin. Spread the cream evenly and carefully, pay particular attention to vulnerable areas such as between the fingers and around the nails. The cream is also suitable for facial application. The product should not get into the eyes.

The dermatological compatibility of GREVEN® LOTION D has been carefully tested and proven. A printed certificate is available.

COATING COMPATIBILITY

The Fraunhofer Institute for Manufacturing Engineering and Automation confirms the general coating compatibility of GREVEN® LOTION D.

PRODUCT QUALITY

The product is manufactured according to GMP (GOOD MANUFACTURING PRACTICE) requirements. The bacteria count is microbiologically tested on a regular basis and is under 100 bacteria per gram.

FIRST AID

If GREVEN® LOTION D accidentally gets into your eyes, rinse immediately with plenty of lukewarm water. If a burning sensation still persists, consult an eye doctor as measure of precaution.

STORAGE INSTRUCTIONS

GREVEN® LOTION D will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each tube / bottle.

STATUTORY REGULATIONS

GREVEN® LOTION D is subject to the EU Cosmetics Regulation, but not to the German Chemicals Act or the Hazardous Substances Order. Moreover, skin care products are received as part of the Personal Protective Equipment (PPE).

ENVIRONMENT

All tubes and bottles are made of polyethylene and after being completely emptied, they can be disposed of with other polyethylene waste. The empty packaging should be disposed of in a container specially designed for recycling. Packaging is labelled accordingly. The tube body consists of at least 30 % recycled plastic.

Using the product in the correct amounts minimizes the environmental impact and saves money.

HALAL AND KOSHER REQUIREMENTS

To the best of our knowledge, the ingredients of GREVEN® LOTION D comply with halal and kosher requirements.

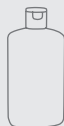
